Keshet Rescue ("Keshet", or "we"), and ______ the undersigned (the "Foster Person" or "you"), in consideration of the mutual covenants in this Agreement and other good and valuable consideration, intending to be legally bound by this Agreement, agree to the following:

1. **The Dog**. We are placing the following described dog with you, the Foster Person, for fostering by you as an indoor/outdoor pet (the "Rescue Dog") pursuant to terms specified below ("Fostering Program"):

2. Foster Care.

- 2.1. The Foster Person accepts full responsibility for maintaining a reasonable level of care for the Rescue Dog, including food, water, grooming, adequate sanitation, exercise, attention, safety, and shelter. The Rescue Dog will be treated with affection and kindness, and never be subjected to abuse, animal research, dog fighting, or use as a guard dog for any agency, corporation, or organization.
- 2.2. You will treat the Rescue Dog as a household pet, companion and family member and not leave the Rescue Dog chained (more than 2 hours), crated and/or otherwise confined for extended periods of time (more than 5 hours at a time). Following a confinement period the Rescue Dog must be allowed unencumbered freedom (for a minimum of the period equal to the period of confinement) within the home and/or a protected run.
- 2.3. When not in the home you will walk the Rescue Dog on a leash, or place the Rescue Dog in a protected run or other enclosed outdoor area, and NEVER allow the Rescue Dog to roam free

unsupervised. You agree to ALWAYS keep the Rescue Dog ON A LEASH or in a SECURELY FENCED AREA.

- 2.4. Underground electric fence containment systems are not to be used. These Rescue Dogs are large dogs with amazing tolerance for pain. An electric fence will not stop them from leaving the "protected" area if something catches their interest. It will also not stop kids or other dogs from approaching them..
- 3. Veterinary Care. When requested, you agree to return the Rescue Dog to us for periodic examinations and shots by a licensed veterinarian. You agree to acquire and provide to the rescue dog all medications prescribed by our veterinarian, including but not limited to rabies and distemper/parvo (DHLPP) and to ensure that the Rescue Dog receives preventative medication to protect against heartworm.
 - 3.1. In case of illness or injury, you agree to seek prompt veterinary care. You further agree to keep all required vaccinations current.
 - 3.2. You consent to using our veterinarian for the Rescue Dog at all times if required for illness or injury.
 - 3.3. You understand and consent to our inspecting your place of residence prior to fostering the Rescue Dog and at any time for the period that the Rescue Dog is in your possession.

4. Identification; Transfer.

- 4.1. You understand and agree that the Rescue Dog is the property of Keshet Rescue and will always be wearing a Keshet Rescue identification tag with our current telephone numbers. In addition, you will make no attempt to disable, change or disrupt the identification chip embedded in the dog. The chip will be confirmed every time a home visit is conducted or the Rescue Dog returns to Keshet Rescue for any reason.
- 4.2. If for any reason the Foster Person cannot keep the Rescue Dog, the Rescue Dog MUST be returned to Keshet Rescue or a designated Keshet Rescue representative. You will not give or allow the Rescue Dog to be given or sold to any individual or organization without written permission of Keshet Rescue. You will not place the Rescue Dog in a DOG POUND or PUBLIC/PRIVATE ANIMAL SHELTER of any kind.
- 4.3. You understand that the use of a crate can ensure an earlier transition for the Rescue Dog and you agree to use a crate on the advice of the Keshet Rescue representative if necessary.
- 5. **Lost Dog.** You agree to make your most serious effort to find the Rescue Dog if it becomes lost, by immediately (a) filing lost reports with Keshet Rescue, the local police, animal control authorities, animal shelters, local veterinarians and pet stores, (b) posting lost dog signs (c) running lost dog adds in your local paper and (d) contacting us for additional advice.
- 6. **No Representations.** You understand that the Rescue Dog was previously unwanted or lost and may have been rescued by us from a dangerous, unhealthy and/or cruel situation. This could have long-lasting effects on the Rescue Dog. You agree that we are making NO REPRESENTATIONS OR WARRANTIES about the condition, health, personality or temperament of the Rescue Dog.
- 7. Indemnification and Hold Harmless. The undersigned Foster Person hereby agrees to release, INDEMNIFY, and covenant to hold harmless Keshet Rescue, its officers, members, agents, and other representatives, from any claims (including for negligence), damages, injuries, costs, or actions incurred as a

result of your entering into this Agreement. You agree to assume all risk of loss and/or injury resulting directly or indirectly from your involvement and participation in the Fostering Program. For clarity, this includes your agreement not to hold Keshet Rescue liable for any spread of disease, damage to property or infliction of bodily injuries to either people or other pets that may result from fostering of the Rescue Dog.

- 8. **Reservation of Rights.** Keshet Rescue reserves the right to an ongoing review of compliance with the terms of this Agreement, including follow-up on any complaints or reports to protect the welfare of the Rescue Dog.
- 9. Remedies Upon Default. Should the Foster Person breach any of the terms of this Agreement or have misrepresented any facts to Keshet Rescue to obtain the Rescue Dog, Keshet Rescue shall have the right to rescind this contract and demand the RETURN of the Rescue Dog. Should the Foster Person fail to return the Rescue Dog, Keshet Rescue may, at its option, a) peaceably enter the Foster Person's property to take possession of the Rescue Dog, or b) seek an order from a court of competent jurisdiction for return of the Rescue Dog and payment of damages and may retain the sum paid for the Rescue Dog pursuant to this Agreement (if any).
- 10. **Attorneys' Fees.** The Foster Person agrees to pay actual attorneys' fees and other costs incurred by Keshet Rescue to obtain the remedy available under Paragraph 11 above.

14. Miscellaneous. This Agreement (including any attachment hereto) is the entire agreement between you and Keshet Rescue, and supersedes any prior understandings between you and Keshet Rescue with respect to the subject matter of this Agreement. No modification of this Agreement will be valid unless in writing dully signed by both you and us. This Agreement is binding upon you and your heirs, assigns, successors, personal representatives and executors, and is governed by the law of the province of Ontario.

Your signature verifies that you have read, fully understand and agree to the conditions for fostering and or adoption set forth in this document.
