Participant Agreement & Release of Liability

In consideration of being permitted to participate in training classes and other similar events and programs being offered by KESHET KENNELS (the "Event") I hereby agree to the following:

1. I, as the owner of _____, hereby certify that to the best of my knowledge the above named dog is in good health, has not been ill with any known contagious diseases within the last thirty days, and has been fully vaccinated for bordetella (commonly known as "kennel cough"), rabies, distemper and parvo in accordance with local laws. I agree that if immediate or emergency care is needed and provided, I shall be solely responsible for the cost of any and all such care.

Please note that no dog shall be exempt from the vaccination requirements unless there is a valid medical reason with proof supplied in writing by a licensed veterinarian. Both a regular flea control program and heartworm testing and preventative are strongly recommended.

2. I am aware that my dog may be exposed to infectious diseases as listed above. However, since KESHET KENNELS has advised me that my dog should be fully vaccinated against those diseases before attending any Event, I alone assume responsibility for any such exposure. I also acknowledge that in addition to the diseases described above my dog may be exposed to other infectious diseases. However, in order for my dog to participate in KESHET KENNELS activities, I alone assume the responsibility of such exposure to all other infectious canine diseases.
3. I understand that at all times my dog must be leashed and under my full control on KESHET KENNELS premises, unless my dog remains under the supervision of a KESHET KENNELS instructor, or within specifically designated and authorized by KESHET KENNELS play area. I agree that in order to attend the Event my dog is required to be well-behaved and sociable around adults, children, and other dogs, and that I, as the owner, agree to be solely responsible for any and all acts or behaviour of my pet while in attendance at such Event. Should my dog become frightened, agitated, or aggressive, I understand that I must take immediate action to gain control over my dog and to remove the dog from the situation. I further understand that KESHET KENNELS reserves the right to physically remove my dog from any situation where a disturbance is created, where my dog appears dominant or aggressive, or that is deemed, at the complete discretion of KESHET KENNELS organizers, to be dangerous or undesirable to my dog or any other dog or person, and that in any such situation we may be asked to leave the Event without financial compensation.
4. I am aware that given the sometimes unpredictable nature of dogs, an interaction could take place between animals at the Event, which may result in an injury to my dog, to other dogs, to me and to other people. I understand that I bear sole responsibility, financial or otherwise, for any such injury or harm afflicted by my dog to any other dog or person while my dog is attending the Event, and that likewise, other people attending the Event bear sole responsibility, financial or otherwise, for any injury or harm afflicted by their respective dogs to my dog or to me during the Event.

If I am mistaken and an unwanted pregnancy results, I take full responsibility for any consequence to my animal.** I hold KESHET KENNELS and the owner(s) of the impregnating dog harmless and indemnify them for any resulting pregnancy and/or complications and/or illness and/or financial costs resulting from such pregnancy.
6. I understand that any photographs, videos or recordings of me, those in my party, or photos of my dog that are obtained during any KESHET KENNELS Event might be used for publicity purposes by KESHET KENNELS.
7. As to KESHET KENNELS, the facility owners, any and all sponsors or participating organizations, directors, officers, employees, volunteers and agents I hereby waive and release any actions, causes of actions, damages, rights, claims or lawsuits which I may have for: (a) any and all personal injury or property damage which may be sustained arising out of any interaction between dogs participating in a KESHET KENNELS Event; and (b) any and all injury, illness or disease sustained by my dog arising out of or stemming from its participation in any and all KESHET KENNELS Events.
